

DRIVING SAFETY COURSE (DSC) OPTIONS

You may be able to require that this charge be dismissed by successfully completing a driving safety course or a motorcycle operator training course, as appropriate. You will lose that right, if on or before your appearance date, you do not provide the Court with notice of your request to take the course. Please read this information carefully and follow the instructions if you wish to take a driving safety course. Contact the Court before your due date if you have any questions.

1. Only persons holding a valid Texas driver's license or are a member of the United States military forces serving on active duty are eligible for this option, and the DSC must be approved by the Texas Education Agency.
2. You are not eligible for the DSC option if:
 - Your offense occurred in a construction zone with workers present.
 - You were passing a school bus.
 - You were speeding 25 MPH or more above the posted speed limit.
 - Your speed was 95 MPH or more
 - You hold a commercial driver's license (CDL).
3. The Court may dismiss only one charge for each completion of a DSC. Any additional violations on your citation must be resolved by the due date.
4. If you are eligible for the DSC option, enter your plea, sign and date the form and return it to the Court with a \$109.10 **CHECK OR MONEY ORDER payable to MERKEL MUNICIPAL COURT, with PROOF OF LIABILITY INSURANCE and copy of current DRIVER'S LICENSE.**
5. Your request may be submitted in person or by certified mail, return receipt requested, on or before the appearance (due) date on your citation. Mailed request must be post-marked on or before the due date to be approved by the Court.
6. If you qualify for the DSC option, you are allowed 90 days from the due date on the plea form to:
 - Complete the DSC and submit the original certificate of completion to the Court. **EXTENSIONS ARE NOT PERMITTED!** Present to the Court a copy of your driving record. The form to request this document may be obtained from any Department of Public Safety Driver License office; by contacting the Driver License Bureau in Austin at 512/424-2600; P.O. Box 15999, Austin, Texas 78761-5999; or by going to www.tx-dps.com
7. Please detach and retain the portion of this letter containing each Court's address and telephone number. You will need this information when you forward your certificate of completion and driving record to the appropriate Court.

PLEASE READ AND FOLLOW THESE INSTRUCTIONS CAREFULLY

YOUR SIGNATURE on the traffic citation you received is a legal commitment to appear before the Court. This may be done in person or by signing and mailing this letter to the Court. If you do not respond on or before the appearance (due) date noted on the bottom of your citation, a FAILURE TO APPEAR charge, which carries an additional FINE OF UP TO \$500.00 can be filed against you. Warrants will be issued for your arrest and your driver's license will not be renewed.

If you hold an out-of-state driver's license, failure to comply with this citation could result in suspension of your driver's license in your home state under the non-resident violator compact agreement.

NOT GUILTY means you will be set for pre-trial hearing. Mail this letter and a copy of citation to the court which will notify you by mail of your court date. You MUST be present in court at the time and date set for your pre-trial.

GUILTY OR NO CONTEST (NOLO CONTENDERE) fines are the same. Either plea indicates you agree to waive appearance for trial. Enter a plea, sign and date this letter, and mail it with a CHECK or MONEY ORDER for the amount shown on the fine schedule on the reverse side of this form.

MUST ENTER YOUR PLEA BELOW

_____ I hereby enter a plea of NOT GUILTY and request a court date for a pre-trial hearing.

_____ I hereby enter a plea of GUILTY and waive my right to a trial by jury,

_____ I hereby enter a plea of NO CONTEST and waive my right to a trial by jury.

OPTIONS AFTER ENTERING PLEA

_____ Having made a plea of No Contest or Guilty, I hereby request the opportunity to take a Texas Certified Driver's Safety Course. Must contact Court.

_____ Having made a plea of Guilty or No Contest to the charge, I hereby request Deferred Disposition. I understand that to make this request I need to make a plea of Guilty or No Contest, pay the full amount of fine and fees due, and that I will be placed on a 90-day deferral period. If I complete the 90-day deferral period and have no other charges, citations, filed against me, the charge will be dismissed. *If under 25 years of age you will be required to take a mandatory Driver's Safety Course. Must contact Court.*

MERKEL MUNICIPAL COURT FINE SCHEDULE

SPEEDING VIOLATIONS/FINE AS FOLLOWS: Up to 15 mph over \$120.00 (Base fine & Court Costs) + \$2.00 per mile over posted speed limit.

Example: If you were speeding 40 mph in a 30 mph zone - you would figure \$120.00 + (\$2.00 x 10 miles) \$140.00. 15 mph or over, must contact the Court.

SCHOOL ZONE VIOLATIONS:

\$140.00 (Base fine & Court Costs) + \$5.00 per mile over the posted speed limit

Example: If you were speeding 30 mph in a 20 mph zone - you would figure \$140.00 + (\$5.00 x 10 mph) = \$190.00

DRIVER RESPONSIBILITY PROGRAM

Effective September 1, 2003, the State of Texas adopted a program that assigns points to a person's driver's license for certain moving violations. Basically, (2) two points are assigned for each conviction arising out of a separate transaction; (3) three points if the violation resulted in an accident. Additional information can be found in Chapter 708 of the State of Texas Transportation Code.

IMPORTANT MESSAGE

Annually, traffic law violations are recorded as a factor in about 85% of the rural traffic accidents in Texas. Approximately 60% of the traffic deaths in Texas occur on rural highways. The enforcement actions taken against you and any subsequent court actions are intended to secure compliance with the traffic laws by you and all other users of the highways. **Failure to comply with your written promise to appear in court as made on this citation will constitute a separate offense with which you may be charged and result in warrants begin issued for your arrest. Failure to appear in court or failure to satisfy a judgment ordering payment of a fine and cost in the manner ordered by the Court may result in the denial of renewal of your driver's license.**

Fail to Maintain Financial Responsibility: "A second or subsequent conviction of an offense under the Texas Motor Vehicle Safety Responsibility Act will result in the suspension of your driver's license and motor vehicle registration unless you file and maintain proof of financial responsibility with the Department of Public Safety for two (2) years from the date of conviction. The department may waive the requirement to file evidence of financial responsibility if you file satisfactory evidence with the Department showing that at the time the citation was issued, the vehicle was covered by a motor vehicle liability insurance policy or that you were otherwise exempt from the requirements to provide evidence of financial responsibility."

If you are convicted of a Misdemeanor offense involving violence where you are or were a spouse, intimate partner, parent or guardian of the victim or are or were involved in another, similar relationship with the victim, it may be unlawful for you to possess or purchase a firearm, including a handgun or long gun, or ammunition, pursuant to Federal Law under 18U.S.C. Section 922(g) (9) or Section 46,04(b), Texas Penal Code. If you have any questions whether these laws make it illegal for you to possess or purchase a firearm, you should consult an attorney.
