OPEN MEETING

1. **Call meeting to order** and announce a quorum is present.
2. **PLEDGE OF ALLEGIANCE and TEXAS PLEDGE.**
3. **Citizens Comments and Receipt of Petitions** (At this time, anyone may be allowed to speak on any matter other than personnel matters or matters under litigation for a length of time not to exceed three (3) minutes. *(No Council/Board discussion or action can take place on any matter until such matter has been placed on an agenda and posted in accordance with the law).*)
4. **Consider** approval of the minutes of the September 10, 2018 Regular City Council Meeting and the minutes of the September 11, 2018 Called City Council Meeting.
5. **Staff Reports.**
6. **Consider** 1st reading of Ordinance No. 11122018 an Ordinance of the City of Merkel, Taylor County, Texas, entitled "Nuisance ordinance" defining what constitutes a public nuisance; prohibiting allowing a public nuisance to exist; providing procedures for abatement of a public nuisance; prohibiting illegal dumping; regulating substandard buildings; repealing conflicting ordinances; providing for exceptions; providing a severability clause; declaring a penalty; and establishing an effective date.

ADJOURNMENT


All items on the agenda are for discussion and possible action.
