This notice is posted pursuant to the Texas Open Meetings Act, (Vernon's Texas Code Annotated, Government Code, Chapter 551)

The City Council of the City of Merkel, Texas will hold a Regular City Council Meeting at 7:00 PM, November 13, 2018 at Heritage Hall which is located at 111 Taylor Street, Merkel, Texas 79536 at which time the following items will be considered:

OPEN MEETING

1. **Call meeting to order** and announce a quorum is present.
2. **PLEDGE OF ALLEGIANCE and TEXAS PLEDGE.**
3. **Citizens Comments and Receipt of Petitions** (At this time, anyone may be allowed to speak on any matter other than personnel matters or matters under litigation for a length of time not to exceed three (3) minutes. *(No Council/Board discussion or action can take place on any matter until such matter has been placed on an agenda and posted in accordance with the law).*)
4. **Consider** approval of the minutes of the October 9, 2018 Regular City Council Meeting.
5. **Staff Reports.**
6. **Consider** 4th Quarter FY 2017-2018 Quarterly Investment Report.
7. **Public Hearing** to allow public input on proposed revisions to the City of Merkel Nuisance Ordinances including adoption of Chapter 683 of the Texas Transportation Code and Chapter 365, the Texas Litter Abatement Act of the Texas Health and Safety Code.
8. **Discuss/Consider** Ordinance No. 11122018 an Ordinance of the City of Merkel, Taylor County, Texas, entitled "Nuisance Ordinance" defining what constitutes a public nuisance; prohibiting allowing a public nuisance to exist; providing procedures for abatement of a public nuisance; prohibiting illegal dumping; regulating substandard buildings; repealing conflicting ordinances; providing for exceptions; providing a severability clause; declaring a penalty; and establishing an effective date.

ADJOURNMENT


All items on the agenda are for discussion and possible action.
