7. **Discuss/Consider** 1<sup>st</sup> Reading of ORDINANCE NO. 01-14-2019 AN ORDINANCE OF THE CITY OF MERKEL, TAYLOR COUNTY, TEXAS, DECLARING A JUNKED VEHICLE, INCLUDING A PART OF A JUNKED VEHICLE, TO BE A PUBLIC NUISANCE; PROHIBITING A JUNKED VEHICLE FROM BEING VISIBLE FROM A PUBLIC PLACE OR A PUBLIC RIGHT-OF-WAY; PROVIDING FOR DEFINITION OF A JUNKED VEHICLE; PROVIDING PROCEDURES FOR ABATEMENT OF A JUNKED VEHICLE; PROVIDING FOR EXCEPTIONS; PROVIDING A SEVERABILITY CLAUSE; DECLARING A PENALTY; AND ESTABLISHING AN EFFECTIVE DATE.
