3. ***Citizens Comments and Receipt of Petitions*** (At this time, anyone may speak on any matter other than personnel matters or matters under litigation for a length of time not to exceed three (3) minutes. ***(No Council/Board discussion or action can take place on any matter until such matter has been placed on an agenda and posted in accordance with the law).***
4. ***Consider*** approval of the minutes of the May 8, 2023, Regular City Council Meeting, the May 16, 2023, and the May 31, 2023, Called City Council Meetings.
5. ***Staff Reports.***
6. ***Discuss/Consider*** appointing City Judge.
7. ***Consider*** Ordinance No. 06122023 an Ordinance of the City of Merkel, Texas adopting a Juvenile Curfew Ordinance to regulate the movement of persons under 17 years of age at night; providing a penalty not to exceed the sum of five hundred dollars (\$500.00) for each violation of this ordinance; providing affirmative defenses; and establishing an effective date.


