JOB SUMMARY

This position is a fully commissioned Peace Officer who works with and aids the administration and student body of the Merkel Independent School District schools. Serves as a consultant, instructor and problem solver and works to reduce crime through education and the promotion of positive police/student relations. This position is tasked as the dedicated departmental juvenile investigator whose primary responsibility is all criminal investigations where a juvenile is specifically named as a primary suspect and crimes against person(s) cases where a juvenile is the primary victim.

ORGINIZATIONAL STRUCTURE

Reports to: Chief of Police

Directs: N/A

Other: This position holds an administrative rank of Sergeant. In certain instances, as delegated by the Chief of Police, may have supervisory responsibilities throughout the duration of certain investigations where additional departmental staff is required/requested.

DUTIES, FUNCTIONS AND RESPONSIBILITIES

Essential duties and functions include the following:

- Educate youth by providing relevant and informative educational programs as requested by staff.
- Provide problem resolution, counseling and enforcement when necessary.
- Serve as liaison between MISD and the MPD by coordinating police/school shared activities.
- Solicit, promote and present crime prevention and police community relation programs in school and/or any youth/parent/school group that has a potential impact on juvenile crime.
- Consult with students, parents, teachers, and school officials and generally render assistance at every reasonable opportunity.
- Be knowledgeable on referral agencies and their services and provide this information to any requesting party.
- Divert juveniles from criminal activity and when possible, out of the criminal justice system.
- Maintain an active, productive calendar of scheduled school security activities.
- Be responsible for learning applicable services and be able to present them on short notice.

- Work with other team members and management in a positive, productive manner.
- Provide information to all requesting police agencies that aids their school security/crime prevention/community relations programs and/or affects their juvenile crime.
- Perform Law Enforcement and/or social maintenance role as the need arises.
- Perform any task, service or assignment as requested by MISD and approved by the Merkel Police Department.
- Disseminate citizen input to the appropriate administration as applicable. This includes, but is not limited to, suggestions on training, citizen's praise or criticism of officers or policies, etc.
- Promote and participate in community youth recreation programs.
- When school is out for summer, work with the MISD and MPD, as directed.

Essential duties and functions also include; (Standardized Duties for Police Officer)

- Patrols an assigned zone on foot, on bicycle, and by vehicle to detect and deter criminal activity and traffic violations.
- Enforces traffic and parking laws.
- Receives information on activity in an area and assists in plans to address problems.
- Responds to calls relayed by Communications Officers, including but not limited to domestic disputes, assaults, burglaries, traffic accidents, lost or missing persons searches, public service duties, stranded motorists, and others.
- Gathers information/probable cause to secure either arrest or search warrants as needed.
- Conducts preliminary investigations into traffic accidents and other incidents, including but not limited to interviewing victims, complainants and witnesses, gathering information and evidence, and securing crime scenes.
- Process crime scenes to recognize, collect and preserve evidence.
- Apprehends arrest, and process offenders, including fugitives; subpoenas witnesses and serves warrants.
- Provides assistance and backup support to other officers and emergency service providers as necessary.
- Assists motorists.
- Performs bailiff duties at Municipal Court.

- May provide first-aid and CPR to victims as necessary.
- Provides traffic direction as needed for special events such as parades, funerals, athletic events, and school crossings.
- Preparing for and attending court proceedings as necessary.
- Completes all required reports and forms, including accident and incident reports.
- Inspects and maintains assigned patrol car, uniform, and equipment.
- May serve as Hazardous Materials Technician.
- Serves criminal and court-related paperwork.
- Participating in mandatory and elective training.
- May serve as a member of the department's SRT team.
- May serve as a field-training officer for the department.
- May serve as School Resource Officer/Juvenile Officer; provides mentorship and instruction to school children.
- May serve as relief supervisor in the absence of the Chief of Police.
- May be on call after hours to respond to emergency situations.
- Performs other duties as assigned.

KNOWLEDGE, SKILLS AND ABILITIES REQUIRED BY THE POSITION

- Basic NASRO Certification Required or attainable within allotted time period.

Guidelines include state and federal laws, traffic laws, city ordinances, court rulings, constitutional guidelines, training manuals, city, department, and district policies and procedures, and supervisory instructions. These guidelines are generally clear and specific but require some interpretation in application.

COMPLEXITY

The work consists of related law enforcement duties and duties that are outlined within the interlocal agreement between the MISD and MPD. The varied nature of calls within an ISD campus and the potential for emergencies contribute to the complexity of the work. Officer must display the ability to rapidly make well informed, accurate decisions in critical situations.

SCOPE AND EFFECT

The purpose of this position is to protect life, property, preserve the peace and enforce federal, state, and local laws within the Merkel Independent School District, including, but not limited to, ISD campuses, vehicles in transit to and from ISD events, and areas of responsibility not on a campus. Successful performance helps ensure the safety and wellbeing of the students and faculty of the district and citizens and contributes to the efficient and effective operation of the department.

PERSONAL CONTACTS

Primary contacts will be MISD faculty and administrators, students, parents, and guardians. Other contacts are typically with co-workers, other city employees, other emergency service providers, court system personnel, attorneys, judges, medical personnel, law enforcement officers from other agencies, and the public.

PURPOSE OF CONTACTS

Contacts are typically to give or exchange information, provide services, interview persons, resolve problems, and negotiate or settle matters.

PHYSICAL DEMANDS

The work is typically performed while sitting, standing, walking, running, bending, crouching or stooping. The work also requires the ability to climb stairs and to work at varying heights. The employee occasionally lifts light or heavy objects, uses equipment requiring a high degree of dexterity, and must be able to distinguish between shades of color and must have vision acuity to read and recognize objects at various distances. The employee must also use the physical force necessary to arrest and restrain persons.

WORK ENVIRONMENT

Routine exposure to children ranging from all ages, inside MISD facilities, buildings, and athletic complexes. The work is performed indoors, in a vehicle, and outdoors. The employee may be exposed to inclement weather, noise, dirt, dust, contagious or infectious diseases, and life-threatening situations. The work requires the use of protective clothing and devices.
