

ORDINANCE NO. 8192025

AN ORDINANCE OF THE CITY OF MERKEL, TEXAS, AMENDING ORDINANCE NO. 08192024-2 PROVIDING FOR AN INCREASE IN WATER, SEWER UTILITY AND SOLID WASTE RATES.

WHEREAS, certain charges to water utility, sewer utility and solid waste services are necessary to ensure that projected revenues are sufficient to cover projected expenses and financial obligations of the Water Department, Sewer Department and the Solid Waste Service; and

WHEREAS, those rates and charges for water utility, sewer utility and solid waste services have been revised from time to time by the City Council; and

WHEREAS, the City of Merkel's last revision, on August 19, 2024; and

WHEREAS, at this time there is a need to revise current water, sewer and solid waste rates and charges; and

Whereas, the City Council of the City of Merkel is empowered to enact this Ordinance to ensure continued water utility, sewer utility and solid waste service to the Citizens of Merkel and to those receiving water utility, sewer utility and solid waste service outside the City Limits of the City of Merkel, Texas;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MERKEL, TEXAS, THAT:


PART ONE: Ordinance No. 08142024-2 is hereby amended to provide a rate structure as set forth in Exhibit A attached hereto and made part of this Ordinance for all purposes.

PART TWO: The effective date of the action for all customers shall be such that the first billing statement prepared in November 2025, which generally reflects services used in the prior October 2025, and all subsequent billing statements, shall reflect the rates presented in Exhibit A.


PART THREE: That this Schedule of Rates and Charges for Water Utility, Sewer Utility and Solid Waste Services shall be kept on file in the City Secretary's office and in the Water Utility office.

PART FOUR: That if any provision or section of this Ordinance shall be held to be void or unconstitutional, such holding shall in no way affect the validity of the remaining provisions or sections of this Ordinance, which shall remain in full force and effect.
